**NARRATIVE**

On 02-16-11 between 0000 and 0320 in the state of Washington, county of Yakima, 630 Pheasant Crest Dr, West Valley area, Tracy Culton committed a burglary.

On 02-18-11 deputies from the Yakima Sheriff's Office responded to a welfare check at 630 Pheasant Crest. When deputies arrived they discovered a burglary occurred at the residence. Investigators discovered several items were taken from the residence. Items to include jewelry, a laptop computer, digital camera, printer, .22 revolver, women's purses, credit cards, identification all belonging to the victims.


On 05-27-11 Tracy Culton came into the Sheriff's Office on her own to talk about some crimes she had been involved in. In that interview she admitted to being in possession of the jewelry that came from 630 Pheasant Crest and that she took that stolen jewelry and sold it to a private citizen.

On 06-08-11 investigators received information from George Gilbert, chief investigator for the women's prison in Washington State. Gilbert indicated he intercepted email communications from someone outside the prison writing to an inmate in the prison. The email was from Tracy Culton. In the email Culton admitted she was involved in the burglary on Pheasant Crest. She further admitted that she planned the incident.

Request Culton be charged with Burglary 1.
